

**Terms and Conditions**

1. The interested individuals/Parties must have valid logging license that are registered with our Division and must produce during the time of registration.
2. Interested bidder must inspect and verify forest produce at the site given above in consultation with Range Officer, Tsimasham during office hours before the auction date.
3. The interested bidder shall deposit an amount of **Nu. 5000 as Earnest Money Deposit (EMD)** at the time of registration in Demand Draft/ Cash Warrant in favour of Chief Forestry Officer, Gedu **on or before 05:00pm of 14/06/2024**. The EMD shall be refunded to the uncessfull bidder, however, the EMD of successful bidder shall be retained until entire bid value is deposited.
4. The successful bidder shall deposit the 50% of the bid value on the day of auction and the remaining 50% prior to the issuance of coupe clearance by the concerned CFO.
5. In the event of non-deposit of bid value on the day auction, the site will be allotted to next highest bidder.
