Public Notification

The Divisional Forest Office, Pema Gatshel, is pleased to notify all eligible Bhutanese firms or private parties about the following scientific thinning sites for allotment to the private party. The allotment through the lucky dip system will be conducted by the Scientific Thinning Allotment Committee in line with the Modality for the allotment of sites and extraction of timber from Phase II Scientific Thinning Operation through the Private Sector received vide No. DoFPS/FRPMD/FRPIS/01/2024-2025/307 dated October 10, 2024.

The tentative date for site allotment to the private party through the lucky dip will be conducted on **6th December 2024 at Division HQ, Khar, Gamazor at 9.30 AM**. The following requirements shall apply to the interested eligible Bhutanese firm or private sector.

1. All scientific thinning operation areas identified for allotment to the private party shall be allotted through the lucky dip system conducted by the concerned Divisional Forest Office.
2. Possess a valid wood-based industry license (primary or secondary).
3. Registered with the Department.
4. Produce evidence of ownership or authorized hire of at least one cable crane. In the case of a hired cable crane, the cable crane must not be hired by multiple parties and shall produce a letter of authorization to use the cable crane from the owner in case of hire.
5. Produce a valid coupe clearance issued by the concerned CFO, if applicable.
6. A private party shall not be allotted more than one scientific thinning site at a time.
7. The eligible private party or their representative shall register with the concerned CFO to attend the lucky dip system with copies of their trade license and the Department issued registration letter and the letter of power of attorney in case a representative is participating in the allotment.

8. All interested private parties may register with the concerned CFO at least a day prior to the lucky dip allotment date mentioned in this notification.
9. All interested private parties may thoroughly inspect the scientific thinning areas and may assess the quantity and quality of the timbers prior to the commencement of the lucky dip allotment.
10. An amount equivalent to 2% of the sale value at the approved NRPC rate of log shall be deposited as earnest money in the form of a cash warrant or demand draft at the time of registration. The EMD shall be refunded to those who are unsuccessful in the lucky dip.
11. A non-refundable reforestation cost that will be incurred for reforestation of the clear-felled areas of the cable corridors through plantations shall be deposited as upfront payment by the lucky dip winner on allotment of any scientific thinning operation area. The cost shall be determined by the concerned CFO in accordance with existing norms and standards.
12. The private party shall report to the allotment venue at the date and time notified by the CFO, failing which the participants shall not be allowed to participate in the lucky dip.
13. The winning private party shall commence the thinning operations within one month from the date of signing of the Contract Agreement.
14. The thinning operation site allotted to a private party shall be non-transferable.
