Divisional Forest Office, Wangdue would like to invite Expression of Interest (EoI) from Bhutanese firms or private parties in lucky dip system allotment of following scientific thinning sites under Wangdue Dzongkhag:

The firms or private parties participating in the lucky dip system should meet the following criteria to be eligible to register for allotment:

- The eligible party or their representative shall register with the concern CFO to attend the lucky dip system with copies of their valid Trade License and the Registration Certificate (WBI-Primary or Secondary) and letter of power of attorney in the case a representative is participating in the allotment.
- Produce evidence of ownership or authorized hire of at least one cable crane; In case of hired cable crane, the cable crane must not be hired to multiple parties;
- Produce a valid coupe clearance issued by concerned CFO, if applicable.
- Private party shall not have been be allotted with more than one scientific thinning sites at a time.
- All the interested private parties may register with the concerned CFO *at least a day prior* to the lucky dip allotment date mentioned in this notification.
- All interested private parties may thoroughly *inspect the scientific thinning areas* and may assess the quantity and quality of the timber prior to the commence of the lucky dip allotment.
- An amount equivalent to 2% of the sell value at the approved NRPC rate of the log shall be deposited as earnest money in the form of a cash warrant or demand draft at the time
