**Public Re-Notification**

The office of the Jomotsangkha Wildlife Sanctuary, Jomotsangkha is pleased to re-notify all eligible Bhutanese firms or private parties about the following scientific thinning sites for allotment to the private party. The allotment through the lucky dip system will be conducted by the scientific thinning committee in line with the "Modality for the allotment of sites and extraction of timber from phase-II scientific thinning operation through private sector" received vide no. DoFPS/FRPMD/FRPIS/01/2024-2025/307 dated October 10, 2024.

The tentative date for site allotment to the private party through the lucky dip system will be conducted on **27<sup>th</sup> January, 2025** at Jomotsangkha Wildlife Sanctuary conference hall at 9:30am. The following requirements shall apply to the interested eligible Bhutanese firm/private parties.

1. All scientific thinning operation areas identified for allotment to the private party/firms shall be allotted through the lucky dip system conducted by the Park Office.
2. Must possess a valid wood-based industry license(Primary or Secondary) duly registered with any field Divisions or Parks of Department of Forests & Park Services.
3. Produce evidence of ownership or authorized hire of atleast one cable crane. In the case of a hired cable crane, the cable crane must not be hired by multiple parties and shall produce a letter of authorization from the owner.
4. Produce a valid coupe clearance issued by the concerned CFO, if applicable.
5. The eligible private party or their representative shall register with the concerned CFO to attend the lucky dip system with copies of their trade license, registration letter from DoFPS and the letter of attorney in case a representative is participating in the allotment.
6. A private party shall not be allotted more than one scientific thinning site at a time.



7. All interested private parties/firms may register with the concerned CFO at-least a day prior to the lucky dip allotment date mentioned in this notification.
8. All interested private parties may thoroughly inspect the scientific thinning areas and may assess the quantity and quality of the timbers prior to the commencement of the lucky dip allotment.
9. An amount equivalent to 2% of the sale value at the approved NRPC rate of logs shall be deposited as earnest money (EMD) in the form cash warrant/demand draft at the time of registration. The EMD shall be refunded to those who are unsuccessful in the lucky dip.
10. A non-refundable reforestation cost that will be incurred for reforestation of the clear felled areas of the cable corridors through plantation shall be deposited as upfront payment by the lucky dip winner on allotment of any scientific thinning operation area. The cost shall be determined by the concerned CFO in accordance with existing norms & standard.
11. The private party shall report to the allotment venue at the date and time notified by the concerned CFO, failing which the participants shall not be allowed to participate in the lucky dip.
12. The winning private party shall commence the thinning operations within one month from the date of signing the contract agreement.
13. The thinning operation site allotted to a private party shall be non-transferable.
