Notification of Open Auction of Mixed Hardwood Timber

The Divisional Forest Office, Dagana announces an open auction for seized special class timber stacked at Dagana range and mixed hardwood timber (A and B class) along the farm road at Khebisa and Lajab gewogs. The auction is scheduled for March 12, 2025, at 11 A.M. at the Division Head Office, Dagapela. The timber will be auctioned on an “as is where is” basis. Interested individuals or parties are encouraged to inspect the timber at the designated sites during office hours before the auction.

Terms and Conditions

1. Any Bhutanese national with valid CID is eligible to participate in the auction and must deposit a non-refundable registration fee of Nu. 1000.00 at least one day prior to the auction day.
2. The successful bidder shall deposit 50% of the total bid value on the day of the auction and the remaining 50% after completing the extraction of 75% of the allotted timber.
3. The successful bidder shall be responsible for obtaining necessary permits via ofs.dofps.gov.bt and bearing any applicable cost.
4. In the event of a successful bidder withdrawing the work before completion, the CFO shall forfeit the 50% bid value deposited, and the site shall be put up for subsequent auction. The bidder will be barred from participating in future auctions.
5. All bidders shall report to Divisional Forest Office, Dagana, during office hour to inspect the timbers at the site.
6. The successful bidder should lift the timbers within 10 days from the day of allotment. However, if the work cannot be completed within the allotted timeframe, the bidder should inform the CFO for further course of action.
7. The successful bidder will be liable for penalty as per the existing relevant Acts and Rules in case of breaching any of the above terms and conditions.
