**Auction Re-notification**

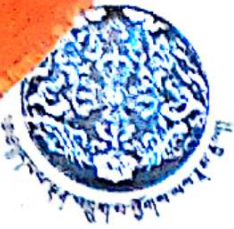

## Jomotsangkha Wildlife Sanctuary

### Terms and Condition

1. Any interested bidders should have valid trade license (Retail/Goods/Items/Non-wood Forest Produces/Export of NWFP) and produce the copy during the time of registration.
2. Representatives attending the auction must produce letter of authorization from the registered party/individual during the time of auction.
3. The bidders will pay Nu.2000/- (Ngultrum Two Thousand) only as the registration fee, which is non-refundable.
4. Each eligible bidders registered for the auction shall deposit bid security of Nu.36000/- (Ngultrum Thirty Six Thousand) only in the form of cash warrant in the name of Chief Forestry Officer, Jomotsangkha Wildlife Sanctuary. The bid security of the winning bidder shall be retained and adjusted against the total value of the product and the bid security of the unsuccessful bidders shall be refunded within a week.
5. Bidders/representatives shall avail token during the registration to participate in the auction.
6. Bidders/representatives shall be assumed to have inspected the product and satisfy themselves before the start of auction.
7. The highest price bidder on the fall of hammer shall win the auction and will allot the product by the committee. In the event, the auction committee disqualifies the highest bidder on the day of auction, the committee shall re-auction the product.
8. The winning bidder shall weigh the product jointly with the sellers in presence of auction committee members for transparency and clean record.
9. The winning bidder shall pay 100% total bidding amount for the product on the same day of auction before transportation from the auction site. Failure to pay the total value within a day shall cancelled the bid and bid security and winning product shall be forfeited.
10. The winning bidder shall obtain necessary permits for transportation applying through Online Forestry System before transportation upon payment of royalty as per prescribed rate.
11. Any undesired complaints arises during the auction shall be dealt by the Auction Committee and decision of the Committee shall be final.
